Finding 223-001 Transportation MOE

NESD's Superintendent, Sean Healy, is working with the Placer Hills Union School District superintendent to provide an afternoon bus, in 2024-25, as was done prior to the COVID 19 pandemic.

The attached documents include the NESD's attempts to find bus service through other providers in the area. A presentation is attached where we looked to lease a bus and provide our own driver. NESD will meet this MOE for the 2023-24 school year with transportation services to Special Education students.

Finding 2023-003 Unduplicated LCFF Pupil Counts

The AERIES attendance software has an option that allows parents to self-designate themselves as low income which came to my attention through this audit process. This designation can be made without providing a free and reduced meal application. To rectify this the food service manager, school secretary and I have created the following procedure.

In October, the food service manager and school secretary will meet to review the AERIES entries using the "CALPADS Programs Reference by Student" report. Those families that have self-designated and still need to submit a free and reduced application will be contacted by the food service manager to request that a form be completed. The food service manager will enter the information into AERIES as received. At the beginning of November, The food service manager will "undesignated" those families that have not submitted a form.

Before calculating the district's LCFF revenue at each reporting period, I will print a report from CalPads and Mealtime to tie out the UPP count and make the appropriate inquiries and adjustments.

For the 2023-24 school year, The food service manager has taken the AERIES report and checked that against the free and reduced applications received. I will subtract the number of

students she has provided from the CALPADS report to reach an accurate UPP percentage. Once the data is updated in AERIES and uploaded to CalPads the UPP should be correct for 2nd Interim. We may need to change the timeline of this procedure based on the timelines of AERIES information being uploaded to CALPADS.

2023-003 - MATERIAL WEAKNESS - STATE COMPLIANCE - UNDUPLICATED LOCAL CONTROL FUNDING FORMULA PUPIL COUNTS (40000)

<u>Criteria</u>: Any student who meets the federal income eligibility criteria or is deemed to be categorically eligible for FRPM under the National School Lunch Program (NSLP) will be counted as FRPM-eligible. Except for directly certified and foster students identified through a statewide match, LEAs must submit the appropriate student program (SPRG) records to CALPADS in order for the students to be counted as FRPM-eligible. Authority cited: Section 14502.1, Education Code. Reference: Sections 14502.1, 14503, 2574(b)(3)(C), 44238.02(b)(3)(B), and 41020, Education Code.

<u>Condition:</u> In testing performed on a sample basis, a total of three (3) students were improperly identified as the Free and Reduced Meal Program in the District's CALPADS reporting for the 2022-23 school year for the purposes of Unduplicated Local Control Funding Formula Pupil Counts. The extrapolated impact of this error is a total of 24.0 students reported as FRPM eligible on the District's CALPADS reporting for the 2022-23 school year.

<u>Context:</u> We performed the audit procedures enumerated in the State of California 2022-23 Guide for Annual Audits of K-12 Local Education Agencies and State Compliance Reporting and identified an initial error.

<u>Effect:</u> The District is out of compliance with state requirements for Unduplicated Local Control Funding Formula Pupil Counts.

<u>Cause:</u> The errors were the result of clerical errors in accounting for unduplicated pupil counts in the CALPADS reporting system.

<u>Fiscal Impact:</u> The Newcastle Elementary School's Unduplicated Pupil Percentage for the 2022-23 school year was originally reported at 24.09% and the revised Unduplicated Pupil Percentage is reported at 21.11%; the fiscal impact is a reduction of LCFF revenues of approximately \$9,893. The Newcastle Charter School's Unduplicated Pupil Percentage for 2022-23 school year was originally reported at 23.21% and the revised Unduplicated Pupil Percentage is reported at 21.94%, the fiscal impact is a reduction of LCFF revenues of approximately \$6,956.
